**Retaliatory Fees:** Retaliatory fees are fees imposed by a Department of Insurance on another state's insurance professionals. These fees are equal to what the applicant/licensees resident state charges insurance professionals. The fees by license and application type, accepted via NIPR, for each applicable state are listed below.
