Due to staff working remotely, mailed transactions will take longer to process. Criminal background checks are taking 10-14 days to be returned from the Oregon State Police. Due to significantly higher than normal volume, applications are taking an additional 2-4 weeks to process and applications that require manual review are taking as much as 4-6 weeks to process.
