KAREN STAKEM HORNIG Chief Executive Officer

Karen Stakem Hornig is the CEO of NIPR, a Kansas City-based technology company that supports the insurance industry. She has led NIPR since July 2014. Ms. Hornig previously served as Deputy Insurance Commissioner for the State of Maryland beginning in 2008, where she assisted in the development of the agency's legislative package, managed the operations of the Maryland Insurance Administration, including the agency information technology division.
